## **TERMS AND CONDITIONS –MT4 STANDARD BONUS 100% ACCOUNT PROMOTION**

### **A. INTRODUCTION**

1. This Client Agreement (hereafter referred to as the “Agreement”) is entered by and between Oroku Edge or Oroku Edge LLC (hereinafter called the “Company” or “us”) on the one part and the Client, which may be a legal entity or a natural person who has completed the Account Opening Application Form and has been accepted by the Company as a Client (hereafter referred to as the “Client” and/or “you”) on the other part. The Company is incorporated under the laws of Saint Vincent and The Grenadines with registration 1099 LLC 2021. The Company is authorized as an International Business Company under the Limited Liability Companies Act, Chapter 151 Of The Revised Laws Of Saint Vincent And The Grenadines, 2009 (hereafter referred to as the “Law”). The objective of the Company are all subject matters not forbidden by International Business Companies, (Limited Liability Companies) Act, Chapter 151 of the Revised Laws of Saint Vincent And The Grenadines, in particular but not exclusively all commercial, financial, lending, borrowing, trading, service activities and the participation in other enterprises as well as to provide brokerage, training and managed account services in currencies, commodities, indexes, CFDs and leveraged financial instrument.
2. The trading bonus account terms and conditions is an integral part of the Oroku Edge Client Agreement and Policy and provisions set herein are considered as an annex of all Oroku Edge Client’s Agreement and Privacy Policy.

### **B. CONDITIONS OF ELIGIBILITY**

1. Subject to, and without prejudice to, all other business terms and policies, the offer is available to Oroku Edge Client who have satisfied the eligibility criteria for the offer (Eligible Client) as set out in the sections following hereinafter.
2. The MT4 Standard Bonus Promotion may be offered by Oroku Edge from time to time to Client who open real trading accounts (MT4 Standard Bonus) with Oroku Edge, in case where such Client are referred to Oroku Edge via specific websites and/or social networks sites in the context of certain specific promotions, and/or surveys that Oroku Edge may be running from time to time on such specific websites and/or social network sites.
3. Oroku Edge, at its reasonable discretion, offers the “MT4 Standard Bonus 100% Account Promotion” to any Client and /or any countries/regions as it deems appropriate and for as long as Oroku Edge deems to provide it.
4. Only persons who can form legally binding contracts under the laws applicable in their country of residence may participate in “MT4 Standard Bonus 100% Account Promotion”. Without limiting the foregoing, participation in the “MT4 Standard Bonus 100% Account Promotion” is not allowed for persons under the age of 18 or otherwise under legal age in their country in residence (“minors”). If you are a minor, you may not participate in the “MT4 Standard Bonus 100% Account Promotion”

5. Participation of “Intermediaries/related parties in the “MT4 Standard Bonus 100% Account Promotion” is prohibited. If the registration and/or trading data of a participant in the “MT4 Standard Bonus 100% Account Promotion” corresponds with the registration and/or trading information, including but not limited to IP address, of another participant in the “MT4 Standard Bonus 100% Account Promotion”, Oroku Edge reserve the right to regard this matching as a reason for immediate disqualification. ### **C. SPECIFIC MT4 Standard Bonus 100% Account Promotion (Standard Bonus Account) TERMS**

1. This MT4 Standard Bonus 100% Account Promotion is valid starting from 8<sup>th</sup> August 2022 for a limited time on first come first serve basis.
2. This MT4 Standard Bonus 100% Account Promotion for existing client is only valid until 16<sup>th</sup> August 2022. After this period, only new client can claim this Promotion.
3. This MT4 Standard Bonus 100% Account Promotion maximum claim is calculated as accumulative with Standard Bonus 50% Account.
4. The minimum deposit to bonus account (MT4 Standard Bonus 100% Account Promotion) is \$50, while for the minimum withdrawal is \$15.
5. The total of 50\$ on the amount of their first deposit that is made in MT4 Standard Bonus 100% Account with Oroku Edge.
6. Partner’s commission will be running as per usual according to the MT4 Standard Account affiliate.
7. Deposit bonus will be credited automatically from the successful completion of deposit transaction. Deposit bonus will be credited from minimum of \$50 and up to \$3000 (**One Time Only**). 1. The “MT4 Standard Bonus 100% Account” applies to all Client who open real Account with Oroku Edge in accordance with the rules set herein and granted trading benefits may be used for trading purposes only and cannot be withdrawn nor be lost.
2. This Offer is limited to one (1) account per Client and per IP address only, regardless of the numbers of accounts held by the Client.
3. This offer is limited to one (1) account per Client and per IP address only, regardless if the other accounts have claimed the Promotion or not.
4. This offer may be used as a method to increase the maximum potential net position.
5. The stop-out level for accounts included in this promotion is at 30%. Once your margin level reaches 30% the system will start closing your positions automatically, the position with the highest loss will be closed first.
6. Leverage of the single deposit bonus account is changed according to the size of the Equity on the account. Equity is calculated as a sum of Balance and Credit (provided bonus). Oroku Edge reserves the right to terminate, cancel, block, close the Client’s account, or even set off those balance of any bonus promotion and account if Oroku Edge detects any suspicious activity (*Trade Balance, Expert Advisor, Churning, Scalping Robot, scripts and others*) such that Client have tried to manipulate or abuse any promotion related. Oroku Edge reserve the right to change bonus terms and conditions at any time by notifying Client via emails and website.
8. Oroku Edge reserves the right, at its reasonable discretion:
  - To decline registration of any participant in the MT4 Standard Bonus 100% Account Promotion and:
  - Disqualify any participant in the MT4 Standard Bonus 100% Account who tampers or attempts to tamper with the operation of the MT4 Standard Bonus 100% Account or breaches these terms and/or any of the Oroku Edge Client Agreement and Privacy Policy.

    - i. Of such a participant. In these circumstances, Oroku Edge shall not be liable for any consequences of the trading bonus cancellation, including but not limited to, order(s) closure by stop out.

15.
